Stamford Faculty Council Meeting Jan 24, 2022 07:00 PM Eastern Time (US and Canada) Minutes by Johanna Ortner

OPEN COUNCIL DISCUSSION

- I. Minutes approved by Beth, seconded by Bill
- II. 3rd meeting with David Souder hasn't been scheduled; Bill will go back to his AA to ask for a slot and report back; no follow ups from last meeting with David Souder to report
- III. Concerns sent to Bill.
 - 1. Increasing accommodation requests received by faculty:
 - One of the future speakers to think about should be Emily Sears (CSD Stamford) to come in and discuss the growing number and growing lists of various accommodations and how faculty is supposed to handle all these requests. Claudia mentions that accommodation letters are so complex and weirdly worded that it's difficult to interpret. There have been reports of unreasonable accommodations such as recording and re-organizing an entire class for one single student. Afraid there's no boundary to what's feasible to do for instructors. Jane states that if university puts that burden on the faculty, it's the university's job to figure it out and fix it. Claudia mentions that some students who receive accommodations do not use these accommodations they are given; faculty goes through all the effort and some students don't even need it.
 - Beth states that if university doesn't provide accommodations they are in violation of federal law, however, it is not up to individual faculty to go above and beyond, the university needs to provide the help and support to make these accommodations doable. E.g. CSD should talk to the IT department to figure out how to record the class, it shouldn't be on the individual instructor. Marie will invite Emily Sears for a Monday meeting and will also reach out to Katlyn Griffin to discuss Mental Health and Suicide prevention in another council meeting. Bill mentions that another issue is that students seem to not be aware of CSD. We aren't sure about the roles and responsibilities.
 - 2. Fred Roden addresses the concern with the Stamford English department budget in regard to a proposal that has been in talks about full-time faculty for the FYW program. The proposal forsees that there would be a range of different positions: APIRS, visiting profs for these full-time positions. The word from the department is that the proposal that's on the table would not disqualify people who are current adjuncts. According to Fred, the bigger issue is that this has been an ongoing concern for 5 years, lack of financial support for FYW, and there was never any money for it; currently, there seems to be no clarity on where the money is coming from, but should this go forward, it's not that adjuncts would just be pushed out, but there's also no sense that positions will have been approved.

- Jane mentions that the one full time position that was recently filled was was replaced by someone from Storrs, they weren't transparent with how the process was. Fred mentions that that search was done by the department, this current proposal is a search spearheaded by the Dean's Office. The proposal is coming out of the dean's office to address the fact that specifically adjunct faculty are covering the entire FYW at UConn Stamford; it's not to eliminate the adjuncts, but instead have some of the teaching done by faculty that will be full time. The English department is very clear that the communication that has been made with the dean's office is not a proposal that keeps adjuncts away from applying; currently FYW instructors as adjuncts are not being paid through English department, but through overall UConn budget; that proposal would mean that full time would be paid through English.
