 - (a) SFC: The charge of the Stamford Faculty Council is to advocate for the Stamford faculty in key areas, including, but not limited to: Academics, Faculty Working Conditions, Campus Space Planning, Student/Faculty Matters, and Advising. All SFC members are elected and are UConn/Stamford faculty.

- (i) Compliance is wavering / Countless non-compliance examples documented by Faculty
- (ii) Class size w/ lack of social distancing for unvaccinated is a major concern for faculty.
- (b) Class capacity
 - (i) Claudia: We should be our own advocate. Due to our room sizes, our classes are limited (compared to class sizes in Storrs). There are larger classrooms in the dorms. Therefore, it has been decided to dismiss this topic.
 - (ii) We know W classes = 19, Labs = 20, What is it for other classes in Stamford, e.g., Q?
 - (iii) Need a Supervisor to lead the 16, 1st year writing professors
 - (iv) Suggestion: Implement a Stamford-wide policy that asks Stamford Faculty if they would be willing to increase class size before it is just increased?
 - (v) Faculty wants to be well prepared for class. We want to do our job professionally.
